The undersigned _____, on his/her own behalf and/or as parent or legal guardian of _____, a minor (hereinafter "Minor") hereby grants permission for the undersigned and/or the Minor to participate in dance classes, performances, workshops, competitions and other related activities conducted by Company K Dance, LLC (hereinafter "Company K Dance") for which the undersigned and/or the Minor has registered (collectively the "Activities" and individual an "Activity") and agrees as follows:

Medical: The undersigned: (a) certifies that he/she or the Minor is in proper physical condition to participate in all Activities for which he/she or the Minor is registered and does not have any known physical conditions which could affect his/her or the Minor's participation in the Activities; (b) acknowledges that participation in dance classes and activities subjects him/her and/or the Minor to the possibility of physical illness or injury (minimal, serious, catastrophic and/or death) and possible exposure to COVID, as participants in the Activities are not required to prove immunization against COVID or to wear masks unless required to do so by state or local guidelines; (c) agrees that he/she and/or Minor is voluntarily assuming all of such risks, responsibility and liability concerning the undersigned's and/or the Minor's illness, injury, health, safety and/or possible exposure to COVID by participating in the Activities; (d) agrees that in the event of such illness or injury, the undersigned, on his/her own behalf and/or on behalf of the Minor hereby authorizes Company K Dance to obtain emergency and necessary medical treatment for him/her and/or the Minor; and (e) agrees that the undersigned will be responsible for any and all medical and related bills that may be incurred on behalf of the undersigned and/or the Minor for any illness or injury that the undersigned and/or the Minor may sustain from participation in the Activities and while traveling to and from any site for the Activities or the location from which the undersigned and/or the Minor is participating in the Activities, whether or not the Activities actually occur.

Physical Contact: The undersigned hereby acknowledges that dance education sometimes requires hands-on instruction as well as verbal instruction, and instructors may sometimes correct dancers by touching their arms, legs, feet, hips, back and head to move them into the correct positions; that this is a common standard in dance instruction; and it is his/her or the Minor's responsibility to communicate clearly with any instructor and/or the owners of Company K Dance if any form of such touch is unacceptable to him/her or the Minor.



Photographs and Likenesses: The undersigned acknowledges that as participant and/or a spectator at the Activities, the undersigned and/or the Minor may be included in recordings, streaming, videotapes, photographs, DVDs, podcasts and videocasts taken during the Activities. The undersigned, on his/her own behalf and/or on behalf of the Minor, hereby assigns, transfers and grants to Company K Dance, and its successors, assignees, licensees, sponsors, the exclusive right to photograph and/or videotape the undersigned and/or the Minor and to utilize such videotapes and photographs and the undersigned's and/or the Minor's name, face likeness, voice and appearance as a part of the Activities or in any other media now in existence or hereafter developed, in advertising and promoting the Activities, in advertising and promoting similar future events, on any website of Company K Dance, or in advertising and promotions relating to Company K Dance without reservations and limitations and without compensation. The undersigned further understands that neither Company K Dance nor any third party is under any obligation to exercise any of the foregoing rights, licenses and privileges herein granted. The undersigned waives any right to inspect or approve any materials related thereto.

Actions of Third Parties: The undersigned acknowledges that Company K Dance is not responsible for errors, omissions, acts or failures to act of any third party, including, but not limited to, teachers, employees, students, parents and bystanders.

Rules, Codes and Policies: The undersigned acknowledges having had an opportunity to review the rules, codes and policies of Company K Dance, and agrees, on his/her own behalf and on behalf of the Minor, to abide by all such rules, codes and policies put in place before or at any time during his/her or the Minor's participation and agrees that violation of any rule, code or policy can result in dismissal from the Activities with no refund.

Assumption of Risks: The undersigned enters into this Liability Release and Waiver Form voluntarily, and agrees to assume all risks associated with the undersigned's and/or the Minor's participation in the Activities.

Release: For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned, on his/her own behalf and/or as parent or legal guardian of _____, a minor (hereinafter "Minor"), on the Minor's behalf, and on behalf of the undersigned's and/or the Minor's heirs, personal representatives, successors and assigns, hereby fully releases and agrees to hold harmless Company K Dance, its members, managers, employees, contractors, guest artists or instructors, successors, assigns, and sponsors (hereinafter collectively "Releasees") from any and all liability whether caused by negligence of the Releasees, by a third party or otherwise, for any claim, judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the Activities, including any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that the undersigned and/or the Minor may incur or sustain during the Activities, all activities associated with the Activities, and while traveling to and from the site for any offsite Activities or any other location from which the undersigned and/or the Minor is participating in the Activities, whether or not the Activity actually occurs.

Indemnification: The undersigned further expressly agrees to indemnify and hold harmless Releasees against loss from any further claims, demands or actions that may subsequently be brought by the undersigned and/or the Minor or by any other persons on the account of damages of any character (including, but not limited to costs, actual attorneys' fees and other expenses) resulting to the undersigned and/or the Minor in any way from the Activities, including any claim, demands or actions against Releasees on behalf of the actions or omissions of the undersigned and/or the Minor. The undersigned further agrees to reimburse and to make good to Releasees any loss or costs Releasees may have to pay as a result of any such action, claim or demand.

THE UNDERSIGNED, ON HIS/HER OWN BEHALF AND/OR ON BEHALF OF THE MINOR HEREBY WARRANTS: (a) THAT ALL INFORMATION PROVIDED HEREIN IS ACCURATE; (b) THAT HE/SHE HAS READ THIS RELEASE AND WAIVER IN ITS ENTIRETY AND FULLY UNDERSTAND ITS CONTENTS; (c) THAT HE/SHE IS AWARE THAT THIS RELEASE AND WAIVER RELEASES THE RELEASEES FROM LIABILITY AND CONTAINS AN ACKNOWLEDGEMENT OF THE UNDERSIGNED'S VOLUNTARY AND KNOWING ASSUMPTION OF THE RISK OF INJURY OR ILLNESS; AND (c) THAT HE/SHE HAS SIGNED THIS DOCUMENT VOLUNTARILY AND OF HIS/HE OWN FREE WILL.
